NTUC Care (Education Awards) for Tertiary 2025 Fact Sheet



1. About the Programme

1.1. The **NTUC Care (Education Awards) for Tertiary** aims to motivate our lower-income union members' school-going children in Institutes of Higher Learning ("**IHL**") to excel in their studies and level up the playing field.

2. Eligibility Criteria

2.1. <u>Membership</u>

Members who wish to apply for the education award for their child/children ("**awardees**") must have at least 6 continuous months of membership at the point of application and must not be in arrears.

2.2. <u>Awardee Eligibility</u>

The awardees for the education awards are children of union members who were studying in a full-time course in an eligible IHL¹ in Academic Year (AY) 2024. To be eligible, awardees must be enrolled in a full-time course in AY2024 or have graduated in AY2024.

2.3. Income

- Total Monthly Gross² Household³ Income of \$3,800 and below, OR
- Per Capita Income of \$950 and below if Gross Household Income exceeds \$3,800.

3. Award Quantum for Successful Application

Education Level in AY2024	Quantum
Institute of Technical Education (ITE), Polytechnic, LASALLE (diploma), and NAFA (diploma)	\$400
University	\$600

Successful awardees **must** attend the Presentation Ceremony to receive the award quantum.

4. Required Supporting Documents

4.1. Income documents are required from member and <u>all</u> family members living in the same household, except family members who are attending school:

- 4.2. For cases where members / family members have passed the legislated re-employment age at the point of application and are unable to provide income documentation due to mobility issues, unavailability of mobile or laptop devices etc., income documents may not be required from these family members.
- 4.3. For cases where member's family member(s) are holding a Long-Term Visit Pass ("LTVP") and are staying in the same household, the family member(s) may be counted as a valid headcount for the computation of the Per Capita Income if they hold a valid LTVP at the point of application. Members are required to submit the LTVP holders' income documents as well, where applicable.

5. How to Apply

- 5.1. Application opens from 19 June 2025, 1200hrs to 23 July 2025, 1600hrs.
- 5.2. Members who meet the eligibility criteria may submit their applications via OneCARE at <u>https://ucare.ntuc.org.sg/assistance/</u>.

Note: Members are advised to submit their applications before the closing date as late submission will not be processed.

6. How Does the Successful Awardees Receive the Education Award?

- 6.1. Successful members will receive an email notification on their application outcome.
- 6.2. Successful awardees <u>must</u> attend the Presentation Ceremony to receive the award quantum. An email will be sent to the member by **15 September 2025**, notifying them of the awardee's allocated session for the Presentation Ceremony.

6.3. The award quantum will be credited to the bank account submitted on OneCARE system within 30 working days after the last Presentation Ceremony on 18 October 2025, subject to bank clearance.

7. Other Terms and Conditions

If further information and documentation are required to assess the application, the member must cooperate with NTUC to provide the requested information/ documentation. Failure to provide the requested information and documentation in a timely manner may result in the application being declined.
- 7.2. Appropriate action may be taken against members who are found to have falsely declared information, including but not limited to the return of the award and the denial of future assistance.
- 7.3. NTUC shall not be held liable or responsible in any way (including for any claim, demand, losses or damages) for any transfers pursuant to any inaccurate bank details that the member has provided to NTUC or otherwise pursuant to the member's failure to inform NTUC of any subsequent change in any of the bank details.
- 7.4. NTUC reserves the right to amend the terms and conditions for the grant or to terminate the financial aid at its sole discretion without prior notice.
