3) I consent to my personal data being disclosed amongst:

a) NTUC and HSEU of which I will be a member for the purposes of managing my respective membership; and

b) NTUC, HSEU, the Employment and Employability Institute, and NTUC Social Enterprises for the purposes of managing and increasing membership benefits and privileges.
