REIMBURSEMENT BENEFIT FOR CHALET ROOM AND BBQ PIT BOOKING

TERMS & CONDITIONS

- 1. Each CIEU member is eligible to a <u>\$50 reimbursement benefit</u> for the <u>booking of a room</u> (excluding meeting or function rooms) at <u>various eligible chalets</u>*. The benefit is limited to <u>per member per calendar year</u>, starting from 1 August 2017.
- 2. Each CIEU member is eligible to a <u>reimbursement benefit of actual cost or up to \$20</u> for the <u>booking of the BBQ pit</u> at various eligible providers*. The benefit is limited to <u>per member</u> <u>per calendar year</u>, starting from 1 August 2017.
- 3. To apply, members need to <u>fill up and submit the Claim Form</u> together with an <u>original receipt</u> <u>issued by the provider to the member's name</u> and a <u>copy of bank book or statement</u> for account verification.
- 4. By submitting the Claim Form, the member <u>consents to the collection</u>, use and retention of <u>his/her personal data by CIEU</u> for the purposes of processing, servicing and managing his/her benefit claim application.
- 5. The member will <u>inform CIEU immediately of any changes to his/her contact details and/or</u> <u>personal data</u> in order that CIEU is able to contact him/her for all matters relating to the benefit claim application.
- 6. Payment of the reimbursement benefit will be credited to member's bank account.
- 7. <u>Entitlement</u> to the reimbursement benefit shall be on a <u>first-come-first-serve basis</u>. Once the budget set by CIEU has been fully utilized, the reimbursement benefit will be suspended for the rest of the calendar year.
- 8. CIEU shall reserve the right to <u>reject applications</u> based on the below:
 - <u>Membership not in effect during length of stay</u>; or
 - <u>Membership subscription in arrears</u> as at date of submission of claim form.
- 9. CIEU shall reserve the right to make any changes to the reimbursement benefit scheme without prior notification.
