

## **1 MILLION LINKPOINTS MONTHLY LUCKY DRAW 2023**

### **TERMS AND CONDITIONS (T&Cs)**

---

1. These terms and conditions (“Terms and Conditions”) shall apply to the “1 Million Linkpoints Monthly Lucky Draw (“Lucky Draw”) organised by the Membership Services Division, National Trades Union Congress (“NTUC”).
2. By taking part in this Lucky Draw, you agree to be bound by these Lucky Draw Terms and Conditions and all decisions of NTUC in relation to and in connection with this Lucky Draw.

#### **Qualifying Period**

3. The Lucky Draw is from 1 June 2023 to 31 December 2023, both dates inclusive (“Lucky Draw Period”).
4. NTUC reserves the right to amend, in its sole discretion, the Lucky Draw Period.

#### **Eligibility**

5. NTUC Membership is open to anyone above 16 years of age (as of the start of the Lucky Draw Period), except personnel from Singapore Police Force, Singapore Prisons, Auxiliary Police bodies, foreign domestic workers and full-time students.
6. The following categories of people are not eligible to participate in the Lucky Draw:
  - i) All permanent and/or contract employees (“Employees”) of NTUC Administration and Research Unit (ARU) and their immediate family members (i.e. spouses, children, parents, brothers and sisters) (“Immediate Family Members”).
  - ii) All agencies and/or service providers engaged by NTUC (including but not limited to advertising agencies, promotions agencies, printing companies, event management agencies and any persons assisting or who are involved in the Lucky Draw) and their Employees and Immediate Family Members.

7. NTUC has the absolute discretion to determine the eligibility of Participants. Such determination shall be final and conclusive and NTUC is not obliged to give any reason for its determination.

### **Allocation of Lucky Draw Chances**

8. Valid only for newly approved and existing applicants who sign up or renew their NTUC Union Membership from 1 June 2023 to 31 December 2023, both dates inclusive.

9. The following table shows the corresponding chances of winning for each criteria:

Complete first payment with the FairPrice app in-store (Valid at any Kopitiam and FairPrice stores only)	5

10. The applicable fees are non-refundable and non-transferable, and member(s) must not terminate his/her NTUC Membership within 12 months of payment of the membership fees.

11. NTUC has absolute discretion to disqualify any Lucky Draw Participation that does not meet the criteria set out in these Terms and Conditions. Such determination is final and conclusive and NTUC is not obliged to give any reason for its determination.

### **Prize**

12. The Monthly Lucky Draw for a total of 7 winners (i.e. 1 winner each month) to win 1 Million Linkpoints (worth \$10,000) each will be conducted on the last week of the following month and results of the Lucky Draw will be published on NTUC's website.

13. A computerised draw will be conducted to pick out one winner on the following dates in front of an audience at a meeting that is open to the general public; and under the supervision and witness of an external auditor at NTUC Centre, One Marina Boulevard between 2pm to 3pm.

14. The 1 Million Linkpoints are not transferable or exchangeable for cash, gifts and/or any other objects. NTUC accepts no responsibility for any tax or other liability that may arise from the winnings of the 1 Million Linkpoints.

15. This Lucky Draw is only applicable to Unions and Union Members participating in the General Branch (GB) and Ordinary Branch (OB) programme. NTUC reserves the right in its sole and absolute discretion to replace the monthly Lucky Draw prize at any time with one or more item(s) of equivalent value (such value to be determined by NTUC in its sole and absolute discretion) without having to give any prior notice or reason for such replacement. In the event of a dispute, NTUC's decision is final.

16. NTUC's decision on all matters regarding the Lucky Draw is final, conclusive and binding, and no enquiries or appeals, either verbal or written, shall be entertained. All participants including the winner(s) shall accept and abide by any and all decisions made by NTUC concerning, without limitation, these Terms and Conditions, the rules, procedures and regulations of the Lucky Draw.

## **Use of Personal Information**

17. By participating in the Lucky Draw, the Participants (including the Winners) are deemed to have consented to:

- i. the collection, use and disclosure of his/her name, partial identification/passport number, image, voice and/or likeness by NTUC for editorial, advertising, promotional, marketing, crediting the Linkpoints and/or other purposes in relation to the Lucky Draw, without any payment and/or compensation except where prohibited by law; and
- ii. receiving promotional, marketing and other publicity information from NTUC from time to time.
- iii. NTUC Link may collect, use and disclose his/her personal data as provided in the Link membership application, for the following purposes, in accordance with the Personal Data Protection Act 2012 and the Personal Data Protection Policy (“PDP Policy”) of NTUC Link available at <https://rewards.link.sg/legal/privacynotice>: (i) for the conduct and administration of the Campaign, including without limitation to contact the qualifying winners of the Lucky Draw; (ii) to provide any marketing materials that the participants have agreed to receive; and (iii) for any and all purposes set out in NTUC Link’s PDP Policy.

## **General**

18. The decisions of NTUC on all matters relating to or in connection with the Lucky Draw are final, conclusive and binding. NTUC shall not be obliged to give any reason or enter any correspondence with any person on any matter concerning the Lucky Draw.

19. NTUC reserves the right at any time in its sole and absolute discretion to determine and/or amend or vary these terms and conditions without prior notice, including but not limited to cancelling, extending, terminating or suspending this Lucky Draw, the eligibility terms and criteria, the selection and number of winners, and the timing of any act to be done, and all Participants shall be bound by these amendments.

20. NTUC shall not be responsible for any injury, loss or damage suffered as a result of, or in connection with the Lucky Draw and/or redemption or use of the Prizes howsoever arising, including but not limited to, fulfillment of the prize(s), any error in computing chances, any breakdown or malfunction in any computer system or equipment, any notice which is misdirected and/or lost in the post, loss of income, profits or goodwill, direct or indirect, incidental, consequential, exemplary, punitive or special damages of any party including third parties howsoever arising whether in contract, tort, negligence or otherwise. For the avoidance of doubt, cancellation, termination or suspension by NTUC of this Lucky Draw shall not entitle any party to any claim or compensation against NTUC for any and all losses or damage suffered or incurred as a direct or indirect result of the act of cancellation, termination or suspension.

21. In the event of any inconsistency between these Terms and Conditions and any advertising, promotional, publicity and other materials relating to or in connection with the Lucky Draw, these Terms and Conditions shall prevail.

22. The Lucky Draw and these Terms and Conditions shall be governed by the laws of the Republic of Singapore and all Participants (including the Winners) are deemed to have agreed to submit to the exclusive jurisdiction of the Singapore Courts.

23. A person who is not a party to any agreement governed by these terms and conditions shall have no rights under the Contracts (Rights of Third Parties) Act (Cap 53B) to enforce any terms of such agreement.
