

How to Renew Vocational Licence via GoBusiness Licensing (GBL) Portal

Updated as at November 2022

Instructions:

It will take an estimated of 10 to 15 mins to complete the Renewal process.

Step 3: Login with your Singpass for individuals.

Step 4a: Click on “Licence Application” followed by “Renew Expiring Licence”.

Step 5: At the “Renew Licence” page, input licence holder’s NRIC under “Licence No./Licensee ID No.” to continue. Multiple licence holders are only required to renew once.

Step 10.1:

If the option for both MediSave Liabilities and Refresher course have been selected as “No” and yet they are required to fulfil both requirements. System will auto prompt an error notification.

For MediSave Liabilities, licence holders may now check for their MediSave liabilities directly through the [CPF website](#).

For Refresher Course, licence holders are required to undergo the refresher course first prior to licence renewal.

Step 12: Upload supporting documents

Note 1: Medical memo will be required if there is any selection in Yes option at Step 11.

Note 2: Ensure that the uploaded image is clear and of visible quality and file size must not be >2MB.

Note 3: Licence holders who renew via GoBusiness Licensing portal for the first time will be required to upload a passport size photo (400 by 514 pixels, 35mm by 45mm).

Step 13: Click on Next to proceed to payment.
