I certify that all information provided by me is true and correct and I agree to abide and be bound by the following Terms and Conditions

Membership Fees# (\$117 per year)

- authorise NTUC or its Agency to obtain NTUC Union Membership Fees [current fees being \$9 per month] (Jan-Nov); \$18 (Dec)] from me in accordance with the prevailing rates of union/association subscriptions.
