

**TERMS AND CONDITIONS FOR MEMBERSHIP 1-YEAR PAYMENT MAY 2025 CAMPAIGN ORGANISED BY THE NATIONAL TRADES UNION CONGRESS (“NTUC”) (the “Campaign”)**

By participating in this Campaign, the selected NTUC Member agrees to the following terms and conditions:-

1. This promotion is applicable to selected members of the NTUC-affiliated unions and/or associations (“**Selected NTUC Members**”) who have received, read and agreed to marketing message(s) from NTUC (the “**Message**”) between 8 May to 28 May 2025 (both dates inclusive) relating to this Campaign.
2. A Selected NTUC Member who receives the Message shall be eligible to receive 5,000 Linkpoints if, and only if, the eligibility criteria set out in the table below are satisfied:-

The Selected NTUC Member makes 1-year (hereinafter referred as the “<b>Initial Paid Months</b>”) of upfront, non-refundable, payment of NTUC Membership fees;  (Please note that the Union Membership fee is \$117 per annum (comprising \$9 per month from January to November and \$18 in December));</li><li>ii. The Selected NTUC Member has a valid and existing NTUC Membership and is not in arrears at the time he/she receives the Message; and</li><li>iii. The Selected NTUC Member does not terminate his/her NTUC Membership prior to the expiry of the Initial Paid Months.</li></ol>

3. Upon the expiry of the Initial Paid Months, the Selected NTUC Member shall continue paying his/her subsequent NTUC Membership fees on a monthly basis. NTUC may impose or charge the NTUC Membership fees to the Member’s preferred mode of payment, including but not limited to, Trust cards or other credit card(s)/debit card(s) issued by other banks or FAST (Fast and Secure Transfer, for DBS and POSB accounts only) on a monthly recurring basis.
4. Each Selected NTUC Member can only receive the Gift once for the Campaign.
5. The Gift may take up to four months to be credited to the Selected NTUC Member’s Link account, upon the Selected NTUC Member’s satisfaction of the aforesaid terms and conditions.
6. An SMS will be sent to the Selected NTUC Member after the Gift has been credited. It shall be the Selected NTUC Member’s duty to notify NTUC of any changes in his/her mobile number prior to NTUC’s crediting / issuance of the Gift. NTUC shall not be responsible for any matter (including re-issuing or re-crediting the Gift) where the Selected NTUC Member fails to notify NTUC of any changes to his/her mobile number.
7. NTUC may in its sole discretion cancel, terminate, postpone and/or suspend this Campaign, and NTUC’s cancellation, termination, postponement and/or suspension of the same shall not entitle the Selected NTUC Member to any claim or compensation against NTUC for any and all losses or damages suffered or incurred as a direct or indirect result of the act of cancellation, termination, postponement and/or suspension of this Campaign.
8. NTUC reserves the right to vary, delete or add to any of these terms and conditions for this Campaign from time to time at its sole discretion and without prior notice. These terms and conditions shall prevail over the contents of any brochure or other promotional material advertising this Campaign.
9. NTUC’s decision on all matters relating to this Campaign will be final, binding and conclusive on all Selected NTUC Members, and no queries, issues, disputes and/or correspondence will be entertained.
10. This Campaign and the terms and conditions set out herein shall be governed by and construed in accordance with the laws of Singapore, and all Selected NTUC Members agree to submit to the exclusive jurisdiction of the Singapore Courts.
